The editor and contributors

Andrew T. H. Tan is Associate Professor and Convenor for International Studies at the University of New South Wales, Australia. His research on defence and security issues is supported by the university's prestigious Strategic Priority Fund. He was previously Senior Lecturer in Defence Studies, King's College London, and taught at the Joint Services Command and Staff College, Watchfield, United Kingdom. Educated in Singapore, Cambridge and Sydney (where he obtained his PhD), his advice on security issues is sought by governments, armed forces, universities and research institutes. His many journal articles and book reviews have appeared in leading internationally refereed academic journals, such as *Contemporary Security Policy*, *Terrorism and Political Violence*, *Studies in Conflict and Terrorism*, *Harvard Asia Review*, *Korean Journal of Defense Analysis*, *Cambridge Review of International Affairs*, *Contemporary Southeast Asia*, *Asia Pacific Review*, etc. He has written or edited 10 books, including: *Security Perspectives of the Malay Archipelago* (Cheltenham, United Kingdom: Edward Elgar, 2004); *A Political and Economic Dictionary of South-East Asia* (London: Europa Routledge, 2004); *The Politics of Terrorism* (London: Routledge, 2006); *A Handbook of Terrorism and Insurgency in Southeast Asia* (Cheltenham, United Kingdom: Edward Elgar, 2007); and *The Politics of Maritime Power* (London: Routledge, 2007). His latest sole-authored book is *US Strategy Against Global Terrorism: How it Evolved, Why it Failed and Where it is Headed* (New York: Palgrave Macmillan, 2009).

Riad A. Attar is Assistant Professor in the Department of Government, Law and International Affairs at Murray State University. Attar obtained a PhD in Political Science from Texas A&M University–College Station, Texas in 2006, and an MA in Political Science from Midwestern State University–Wichita Falls, Texas in 1997. The focus of Attar's research is on international political economy in general, and on the political economy of defence in particular. His region of interest is the Middle East. His publishing activities include: 'Egypt: State, Security, and Human Rights', in a reference work published by Praeger Security International, 2006; *The Political Economy of Military Spending, Freedom, Conflicts, and Economic Growth in Developing Countries* (Palgrave, 2002); and 'The Determinants of the Liberalization Process in the Middle East', delivered at the International Studies Association, New Orleans, 2002.

Desmond Ball is Professor in the Strategic and Defence Studies Centre at the Australian National University, Canberra, and is generally regarded as Australia's leading strategic analyst. He was Head of the Centre from 1984 to 1991, and is the author or editor of some 30 books and monographs on global strategic matters, regional security developments and Australian defence issues. He has served as a consultant to a wide range of Australian government departments and agencies. In the 1970s and 1980s, Professor Ball was one of the key actors in the conceptual transformation in Australian defence policy away from 'forward defence' and dependence upon 'great and powerful friends' to the defence of Australia

and self-reliance. He has worked on most aspects of Australian defence policy, including defence decision-making processes, force development methodologies, intelligence capabilities, defence acquisition programmes (e.g. the F/A-18 and Jindalee programmes), Australian Defence Force command and control arrangements, Northern agencies and Australian defence infrastructure, including Australian defence industry. Since the early 1980s, Professor Ball has worked increasingly on security developments in the Asia/Pacific region. In addition to his research and publication activities, Professor Ball has been at the forefront of 'second-track' processes of co-operation in the region. He is a founding member of the Steering Committee of the Council on Security Co-operation in the Asia Pacific (CSCAP).

Sibylle Bauer (Germany) is a Senior Researcher with the Stockholm International Peace Research Institute (SIPRI) and Head of the Export Control Project. Previously, she was a Researcher with the Institute for European Studies in Brussels. She has published widely on European export control and armaments issues, including chapters in *The Restructuring of the European Defence Industry* (Office for Official Publications of the European Communities, 2001), *Annuaire français de relations internationales* (French Yearbook of International Relations) (Bruylant, 2001) and *The Path to European Defence* (Maklu, 2003). She is co-author of *The European Union Code of Conduct on Arms Exports: Improving the Annual Report*, SIPRI Policy Paper no. 8 (November 2004). She has contributed to the *SIPRI Yearbook* since 2004.

Richard A. Bitzinger is Senior Fellow at the S. Rajaratnam School of International Studies, Nanyang Technological University in Singapore, where his work focuses on military and defence issues relating to the Asia-Pacific region, including the challenges of defence transformation in the Asia-Pacific, regional military modernization activities, and local defence industries, arms production and weapons proliferation. Mr Bitzinger is the author of *Towards a Brave New Arms Industry?* (Oxford University Press, 2003); 'Come the Revolution: Transforming the Asia-Pacific's Militaries', *Naval War College Review* (Fall 2005); and *Transforming the US Military: Implications for the Asia-Pacific* (Australian Strategic Policy Institute, December 2006). He has written several monographs and book chapters, and his articles have appeared in such journals as *International Security*, *Orbis*, *China Quarterly* and *The Korean Journal of Defense Analysis*. Mr Bitzinger was previously an Associate Professor with the Asia-Pacific Center for Security Studies (APCSS), Honolulu, Hawaii, and has also worked for the RAND Corporation, the Center for Strategic and Budgetary Affairs, and the US Government. In 1999–2000, he was a Senior Fellow with the Atlantic Council of the United States. He holds a master's degree from the Monterey Institute of International Affairs and has pursued additional postgraduate studies at the University of California, Los Angeles.

Mark Bromley (United Kingdom) is a Researcher with the Arms Transfers Programme at the Stockholm International Peace Research Institute (SIPRI). Within the Arms Transfers Programme, his responsibilities include collecting information on Latin America for the SIPRI Arms Transfers Database, which contains information on all international transfers of major conventional weapons since 1950. His areas of research include defence acquisitions within Latin America, transparency in the field of international arms transfers and the illicit trafficking of small arms and light weapons. His publications include: *The European Union Code of Conduct on Arms Exports: Improving the Annual Report*, SIPRI Policy Paper no. 8 (November 2004); *CBMs in Latin America and the Effect of Arms Acquisitions by Venezuela*, Real Instituto Elcano Working Paper (September 2005); *The Impact on Domestic Policy of the EU Code of Conduct on Arms Exports: The Czech Republic, the Netherlands and Spain*, SIPRI Policy Paper no. 21 (May 2008); and *Stemming Destabilizing Arms Transfers: The Impact of European Union Air Safety Bans*, SIPRI Insights on Peace and Security no. 3 (October 2008).

Michael Brzoska studied economics and political science at the Universities of Hamburg (Germany) and Fribourg (Switzerland), completing a Diploma in Economics and a PhD in Political Science (University of Hamburg) in 1985 and habilitation in 1997. He has been Scientific Director of the Institute for Peace Research and Security Policy (IFSH) and Professor at the University of Hamburg since February 2006. From 1994 until January 2006 he was Director of Research at the Bonn International Center for Conversion, Germany. Between 1987 and 1994 he was Project Leader at the Unit for the Study of Armaments, Development and Wars, Institute for Political Science, University of Hamburg. From 1983 to 1986, he was research member and co-director of the Arms Trade and Arms Production Team at the Stockholm International Peace Research Institute (SIPRI), Sweden. His main fields of research are arms control and disarmament, targeted sanctions and sanction reform, economic actors in internal armed conflicts, Europeanization of arms production, international arms transfers, security sector reform, conflict research and global arms industry. Among recent publications are: *Promoting Security: But How and for Whom?* (Bonn: BICC, 2004; co-edited with Peter Croll); and as co-editor with David Law, *Security Sector Reform in Peace Support Operations* (London: Routledge, 2006).

Malcolm R. Davis, an Australian citizen with United Kingdom permanent residency, is currently employed with the Australian Department of Defence at an APS 6 Level as ‘Staff Officer – Strategy’ with Directorate of Navy Strategy and Futures, which is part of Navy Headquarters. He has held this post since November 2007. Prior to this appointment, he was employed as a Lecturer in Defence Studies with the Defence Studies Department, King’s College London, based at the Joint Services Command and Staff College. His PhD, which examined ‘The impact of the RMA in East Asia from a Maritime Perspective’, was awarded in Politics from the University of Hull in July 2003. His academic focus is broadly in the ‘strategic studies and security futures’ realm. Previous research activities have been centred on military ‘transformation’ and the impact of future military technology on the conduct of warfare, including notions of RMAs, Network Centric Warfare, and the future of Air Power and Seapower, particularly in an East-Asia strategic context. He has developed a strong research interest and expertise in issues related to the military utility of space, and broader strategic aspects of ‘spacepower’. He is currently completing a single-authored monograph to be published by Routledge in 2010, entitled *Military Transformation in East Asia – Technology, Warfare and Future Security*.

J. Paul Dunne is Professor of Economics at Bristol Business School, University of the West of England, Bristol and a research affiliate at the Southern Africa Labour and Development Research Unit (SALDRU), University of Cape Town. He was previously Research Professor in Economics at Middlesex University and has held posts at Birkbeck College, Warwick University, Department of Applied Economics and Magdalene College, University of Cambridge, and the University of Leeds. He is an applied economist whose main area of research is the economics of peace, security and military spending, he is chair of the United Kingdom affiliate of Economists for Peace and Security (EPS), and edits the *Economics of Peace and Security Journal* with Jurgen Brauer. His publications include numerous articles in journals, including *Defence and Peace Economics*, *Economic Journal*, *Journal of Conflict Resolution*, *Journal of Peace Research*, *Cambridge Journal of Economics*, *Journal of Industrial Economics*, *European Economic Review* and the *Scottish Journal of Political Economy*. In addition, he is on the Editorial Advisory Board of the *International Review of Applied Economics*, and the Editorial Board of *Defence and Peace Economics* and is an associate editor of the *Cambridge Journal of Economics*.

Iñigo Guevara (Mexico) is currently undertaking a master’s degree in Security Studies at Georgetown University; he is a graduate of the Strategy and Defense Policy course (SDP,

2008) at the Center for Hemispheric Defense Studies (CHDS) at the National Defense University in Washington, DC and holds a Diploma in Public Security Administration from the Instituto de Administración Pública del Estado de Querétaro (IAPQ). He has a BA in International Trade from the Instituto Tecnológico y de Estudios Superiores de Monterrey (ITESM). His main research comprises Latin American armed forces, conventional arms transfers, orders of battle and procurement policy analysis. He is a member of the International Institute for Strategic Studies (IISS) and is in regular communication with the department that produces the annual publication *The Military Balance*. He is also a member of the Military Expenditure and Arms Transfers networks of the Stockholm International Peace Research Institute (SIPRI), which contribute to publications such as the *SIPRI Yearbook*. He forms part of the Collective for the Analysis of Security with Democracy (CASEDE), a Mexico-based NGO. He is the consultant on Latin America for Jane's Armed Forces desk and contributes to the Sentinel series country-risk analysis. He is also a regular contributor to several United Kingdom-based specialized publications.

Yong-sup Han is currently Director of the Research Institute on National Security Affairs and a Professor at Korea National Defense University. He was Special Assistant to the Korean Minister of Defence in 1993 and a Senior Staff Member to the South-North Joint Nuclear Control Commission in 1991–92. He was Research Fellow at RAND Corporation from 1999 to 2000 and a Visiting Fellow in 1999 at the Center for Nonproliferation Studies of Monterey Institute for International Studies. He was also Senior Visiting Fellow at the United Nations Institute for Disarmament Research in 1993. Dr Han holds a master's degree in Political Science from Seoul National University, a master's in Public Policy from Harvard University, and a PhD in Security Policy from RAND Graduate School. His publications include: 'Delving into the Lee Myung-bak Government's New Security Policy', *Korean Journal of Security Affairs*, June 2008; 'Applying European Success of Economic and Security Co-operation to the Korean Peninsula and Northeast Asia', *Korean Journal of Security Affairs*, June 2006; *Peace and Arms Control on the Korean Peninsula* (Kyungnam University Press, 2005); *Sunshine in Korea* (RAND, 2002); 'Time for Conventional Arms Control on the Korean Peninsula', *Arms Control Today*, December 2000; 'North Korean Behavior in Nuclear Negotiations', *The Nonproliferation Review*, Spring 2000; and *Nuclear Disarmament and Nonproliferation in Northeast Asia* (United Nations, 1995).

You Ji is Associate Professor in the School of Social Science, University of New South Wales, Australia. He has published widely on the People's Republic of China's political, military and foreign affairs. He is author of three books: *In Quest of High Tech Power: The Modernisation of China's Military in the 1990s* (1996); *China's Enterprise Reform: Changing State/Society Relations after Mao* (1998); and *The Armed Forces of China* (1999); and numerous articles, of which the most recent include: 'The Soviet Military Model and the Breakdown of the Sino-USSR Alliance', in Thomas Bernstein and Hua-yu Li (eds), *The Soviet Influence on China in the 1950s* (Rowman and Littlefield, 2009); 'China's New Diplomacy, Foreign Policy and Defense Strategy', in Stuart Harris, Qin Yaqing and Pauline Kerr (eds), *China's New Diplomacy: Tactical or Fundamental Change?* (Palgrave Macmillan, 2008); 'Beyond Symbiosis: Redefining Civil-Military Relations in China', in Wang Gungwu and Yongnian Zheng (eds), *China's Grand Transformation* (Routledge, 2008); 'Revolution in Military Thinking', in Bo Huld and Masako Ikegami (eds), *The Strategic Yearbook on East Asian Security* (Swedish National Defence College and the Finnish Defence University, 2008); 'Dealing with Malacca Dilemma: China's Effort to Protect its Energy Supply', *Strategic Analysis*, Vol. 31, No. 3, 2007; 'Unravelling the Myths of the PLA Political Commissars', in David M. Andrew D. James is a Senior Lecturer at Manchester Business School, University of Manchester, United Kingdom, and a Senior Research Fellow at the Manchester Institute for Innovation Research. His research focuses on corporate technology strategy, innovation management and science and technology policy, with a particular focus on the industrial and technological dynamics of the defence, security and aerospace sectors.

Ephraim Kam is Deputy Director of the Institute for National Security Studies (formerly the Jaffee Center for Strategic Studies) in Israel. He served as a Colonel in the Research Division of IDF Military Intelligence. His last position there was Assistant Director of the Research Division for Evaluation. In 1993 he retired from the IDF and joined the Jaffee Center, where he has been deputy director since 1995. Dr Kam took his BA at the Hebrew University of Jerusalem in Middle Eastern Studies and Economics, and his MA and PhD degrees in International Relations at Harvard University. He specializes in security problems of the Middle East and the Arab states, Israel's national security issues, as well as strategic intelligence. During the last 15 years he has specialized in Iranian strategy. His book *Surprise Attack: The Victim's Perspective* (Harvard University Press, 1988) was awarded the National Intelligence Study Center 1988 prize for the best book on intelligence issues. Among his other publications are: *From Terror to Nuclear Bombs: The Significance of the Iranian Threat* (Hebrew, 2004); *The Implications of the Collapse of the Soviet Union on the Middle East* (1991); *The Political Framework of the Palestinian Entity* (1994); and *A Nuclear Iran: What Does It Mean and What Can Be Done* (2007).

Yaacov Lifshitz is currently an independent economic adviser, a member of the boards of various public and private companies, a senior research associate of the Begin-Sadat (BESA) Center for Strategic Studies, and a lecturer at the Ben-Gurion University, in Israel. In recent years his academic interest as a researcher and a teacher has been mainly in the areas of defence economics, economics of terrorism, and social-economic policymaking in Israel. In the past, among other positions in the public and business sector, he served as the Director-General in the Ministry of Finance, the Chief Economic Adviser in the Ministry of Defence, and the Chairman of the Board of Israel Military Industries. He has written the book *The Economics of Producing Defense* (Kluwer Academic Publishers, 2003), as well as articles on defence economics and related issues.

Harsh V. Pant teaches at King's College London in the Department of Defence Studies. Malcolm Hugh Patterson graduated with degrees in history, international relations and two law degrees from the University of New South Wales, Australia. That publication will advance a case for corporate forces to serve in UN operations under a new administrative and criminal justice model. Malcolm

Patterson lives in Sydney where he is a lecturer in the School of Social Sciences and International Studies at the University of New South Wales.

Sam Perlo-Freeman is a Senior Researcher with the Stockholm International Peace Research Institute (SIPRI) Military Expenditure and Arms Production Project, heading SIPRI's work on Military Expenditure. Previously, he was a Senior Lecturer in Economics at the University of the West of England, working in the field of Defence and Peace Economics, in which he is the author of a number of publications, including: 'The Demand for Military Expenditure in Developing Countries', *International Review of Applied Economics*, 2003; and 'Offsets and Development of the Brazilian Armaments Industry', *Arms Trade and Economic Development: Theory and Policy in Offsets* (Routledge, 2004). He has also worked on policy papers for Oxfam and BASIC, contributing to a recent Oxfam report on the impact of arms transfers on the Millennium Development Goals. During his two stints at SIPRI he has contributed to the Yearbooks for 2003, 2004 and 2008, and has co-authored two SIPRI publications: *Armament & Disarmament in the South Caucasus and Central Asia* (SIPRI Policy Paper no. 3, July 2003) and more recently *The Private Military Services Industry* (SIPRI Insight no. 1, September 2008). He is a long-standing member of the United Kingdom's Campaign Against Arms Trade.

Alexander A. Pikayev is Director of the Department for Disarmament and International Security at the Moscow-based Institute of World Economy and International Relations (IMEMO). He is also a member of the London-based International Institute for Strategic Studies (IISS). Dr Pikayev received his MA from the Moscow State University in 1984 and PhD from IMEMO in 1992. He has worked at IMEMO since 1984. From 1994 to 1997 he was a professional staff member of the Russian Duma's Defence Committee. From 1997 to 2003 he directed a Non-Proliferation Programme at the Carnegie Moscow Center and was Editor-in-Chief of the Center's *Nuclear Proliferation Journal*. Dr Pikayev has authored several hundred books, chapters and articles on nuclear disarmament and non-proliferation, Russian foreign and security policy, and military reform. He has spoken to numerous authoritative audiences, including the US Congress, German Bundestag, United Kingdom Parliament and Russian Duma. Dr Pikayev is one of the most frequently cited Russian political experts by international media.

Martin Rupiya is Director of Research (Africa) at the Centre for Security Sector Management (CSSM), Cranfield University, United Kingdom, since June 2008. His portfolio, apart from lecturing on the MSc in Security Sector Management as well as supervising PhD students, includes leading on options for post-conflict recovery, which focus on security sector reform as well as stabilization on the African continent as part of a wider project of stability, peace and development. Before this, he was a Senior Researcher and MilAIDS Project Manager with the Institute for Security Studies (ISS) in Pretoria, South Africa. The move to work in security policy research-oriented establishments followed more than a decade and a half of teaching at various universities, including the Universities of Zimbabwe, Witwatersrand and Rhodes in Grahamstown, South Africa. Rupiya has published extensively on peace and security issues related to conflict and crises on the African continent. His latest work has focused on a region that has turned out to be the most volatile on the African continent: 'A Regional Security Perspective from and for the Horn of Africa', with Alfred G. Nhema, in Hans Gunter-Brauch et al. (eds), *Globalization & Environmental Challenges: Reconceptualising Security in the 21st Century* (Peace Research & Europe Security Studies, AFES-PRESS, 2008).

Elisabeth Sköns is a Senior Fellow at the Stockholm International Peace Research Institute (SIPRI) and the leader of the SIPRI Military Expenditure and Arms Programme. This

programme monitors and analyses trends and developments in these two areas and produces annual surveys for the SIPRI Yearbook. It maintains a database on military expenditure for 167 countries and a database on arms-producing companies, covering the largest companies in the main arms-producing countries apart from the People's Republic of China. Sköns has contributed to SIPRI publications since 1983. Her most recent publications apart from the annual surveys on military expenditure and arms production are: *The Private Military Services Industry* (SIPRI Insight no. 1, September 2008, with Sam Perlo-Freeman); 'Analysing Risks to Human Lives', *SIPRI Yearbook 2007*; 'The Economics of Arms Production', *Encyclopaedia of Violence, Peace and Conflict* (Academic Press, 2008, with Paul Dunne); 'In Search of the Peace Dividend', *The Statesman's Yearbook 2007*; papers on 'The Costs of Conflict' and 'Financing of Peace Missions' for the *International Task Force on Global Public Goods* (Stockholm, 2006); papers on the restructuring of the Western European defence industry in *Mot et avnasjonalisert Forsvar? (Towards a Denationalized Defence?)* (Abstrakt: Oslo, 2005); and a chapter on defence offsets in Finland and Sweden, in *Arms Trade and Economic Development: Theory and Policy in Offsets* (Routledge, 2004).

Thomas Teichler is a Research Associate at the Manchester Institute for Innovation Research, Manchester Business School. He has a PhD from the European University Institute in Florence on the political, industrial and legal aspects of European armaments co-operation. For this purpose he also spent five months at the European Commission, DG Enterprise and Industry, where he worked with the desk officer 'Defence' in 2005/06. For three years he has extensively worked on matters of European and transatlantic security and defence policy in an academic and policy environment at the Robert Schuman Centre in Florence and at the University of Bielefeld. He has presented his research results at numerous international conferences in Europe and the USA.

Mehmet Uye is a PhD candidate at the Department of Economics, Bristol Business School, University of the West of England, Bristol.

Brad Williams is a visiting fellow in the Department of Political Science, National University of Singapore. He is the author of *Resolving the Russo-Japanese Territorial Dispute: Hokkaido-Sakhalin Relations* (London: Routledge, 2007) and co-editor of *Japan, Australia and Asia-Pacific Security* (London: Routledge, 2006). His research interests focus on the international relations of the Asia-Pacific and he has published in several internationally refereed journals, such as *Journal of Asian Studies*, *The Pacific Review*, *Japan Forum*, *Non-proliferation Review* and *Europe-Asia Studies*.

Siemon T. Wezeman is a Senior Fellow at the Stockholm International Peace Research Institute (SIPRI) where, since 1992, he has tracked and analysed international arms transfers as part of the Arms Transfers Programme (formerly Arms Transfers Project). Since 2006 he has been the head of the Arms Transfers Programme. He has published on the arms trade, transparency in arms and security, and on developments in military technology. His research field is global but with a specific interest in conflict areas and Asia. He is a Dutch citizen and holds an MA in Contemporary History from the State University Groningen. He has contributed to the *SIPRI Yearbook* since 1992. His latest publications include work on UN embargoes, European UAV developments, the UN Register of Conventional Arms and on cluster weapons.

Lt Col Isaiah (Ike) Wilson, III, US Army, PhD, is an Associate Professor at the US Military Academy at West Point, where he directs the American Politics, Policy and Strategy programme in the Department of Social Sciences. He is a former army aviator and military strategist with peace enforcement and combat experience in the Balkans in the 1990s and

in Iraq 2003–04, serving on former Chief of Staff of the Army, Gen. Eric Shinseki's Operation Iraqi Freedom Study Group (OIFSG) and later as chief of plans, 101st Airborne Division (Air Assault). Dr Wilson is an accomplished scholar and published author. His recent book, *Thinking Beyond War: Civil-Military Relations and Why America Fails to Win the Peace* (2007) is considered an important early contribution to the contemporary debates over the US war effort in Iraq. Dr Wilson holds master's degrees in public affairs, political science, strategy and theatre operations, as well as a doctorate in government from Cornell University. He is a life member of the Council on Foreign Relations, holds visiting and adjunct professorships at Cornell University, Columbia University and George Washington University, and has served on the faculty of the prestigious National War College in Washington, DC.
